Northeastern Center Emergency Services received approximately 2,258 calls in FY23 with approximately 586 calls from Steuben County.



Services Provided in Steuben County

Steuben County provides the following Substance Use Disorder Treatment Services: Motivational Interviewing, Integrated Treatment for Chemical Dependency, Cognitive Behavioral Therapy/CBT, Illness Management and Recovery, and WRAP-Wellness Recovery Action Plan.

The level of care is determined by uniform assessment tools (ANSA for adults, CANS for children/adolescents) and standardized admission criteria policy. Treatment philosophy, principles, and core values incorporate SAMHSA (Substance Abuse and Mental Health Services Administration) and NIDA (National Institute on Drug Abuse) guidelines.

Northeastern Center strives to identify substance use issues during pregnancy to provide early intervention and treatment to women to ensure healthy pregnancies and healthy infants. Without early interventions, the effects of substance use while in utero can cause life-long challenges. Additionally, untreated substance use disorders negatively affect the family unit. 

Clinical Services Provided in Steuben County

Steuben County provides the following clinical services: Individual, conjoint, and family therapy. Dialectical Behavioral therapy, High Fidelity Wraparound, Motivational Interviewing, and Anger Management. Case Management and ADL training, as well as medication evaluations and medication management, are also provided.
